

## STRUCTURE AND ELIGIBILITY CONDITIONS OF MARIE SKŁODOWSKA-CURIE INDIVIDUAL FELLOWSHIPS (MSC IF)

- Proposals for IFs involve a *single* host organisation (future beneficiary) established in a MS or AC<sup>1</sup>, which becomes the beneficiary in case the fellowship is granted.
- The candidate researcher must prepare the project proposal in liaison with the host organisation, represented by the scientific supervisor. The proposal is submitted on behalf of the host organisation.
- The researchers must fulfil the eligibility conditions by the deadline of submission of proposals.
- Researcher must be in possession of a doctoral degree or have at least four years of full-time equivalent research experience.
